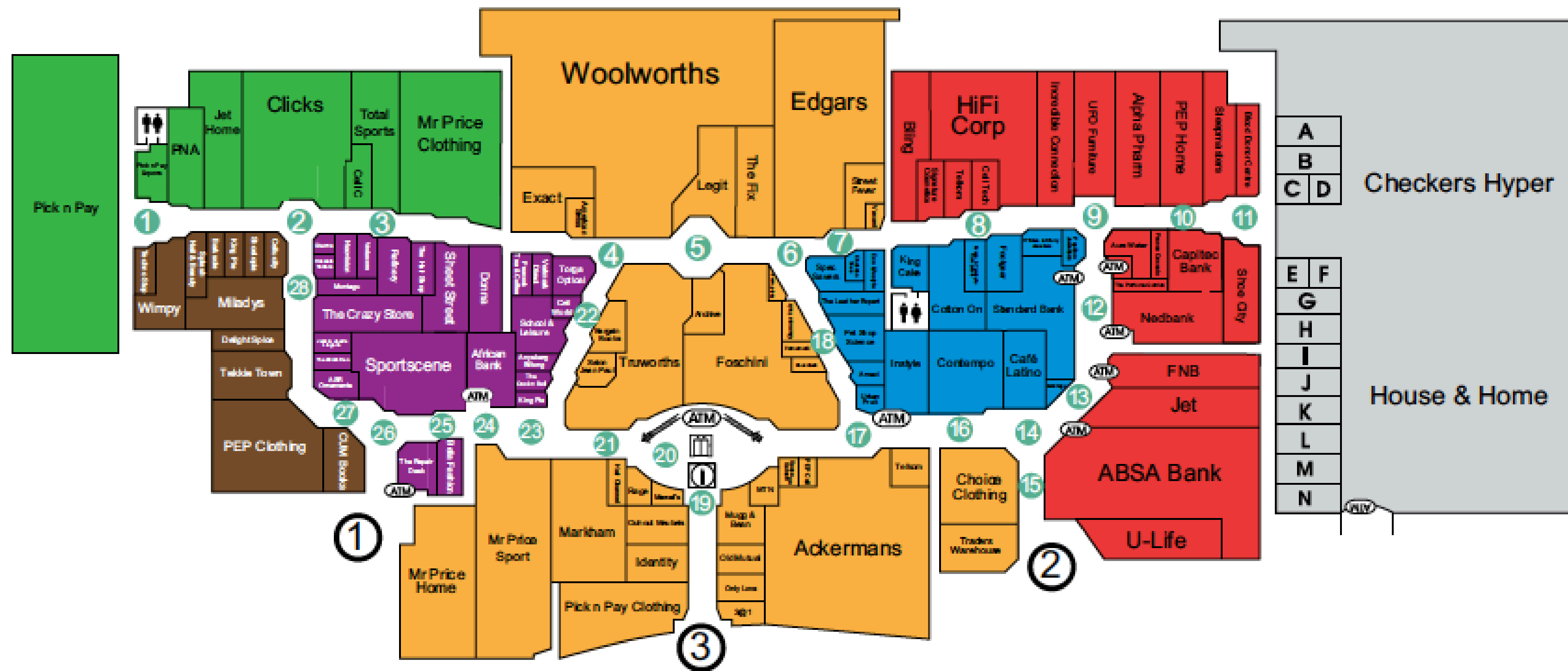

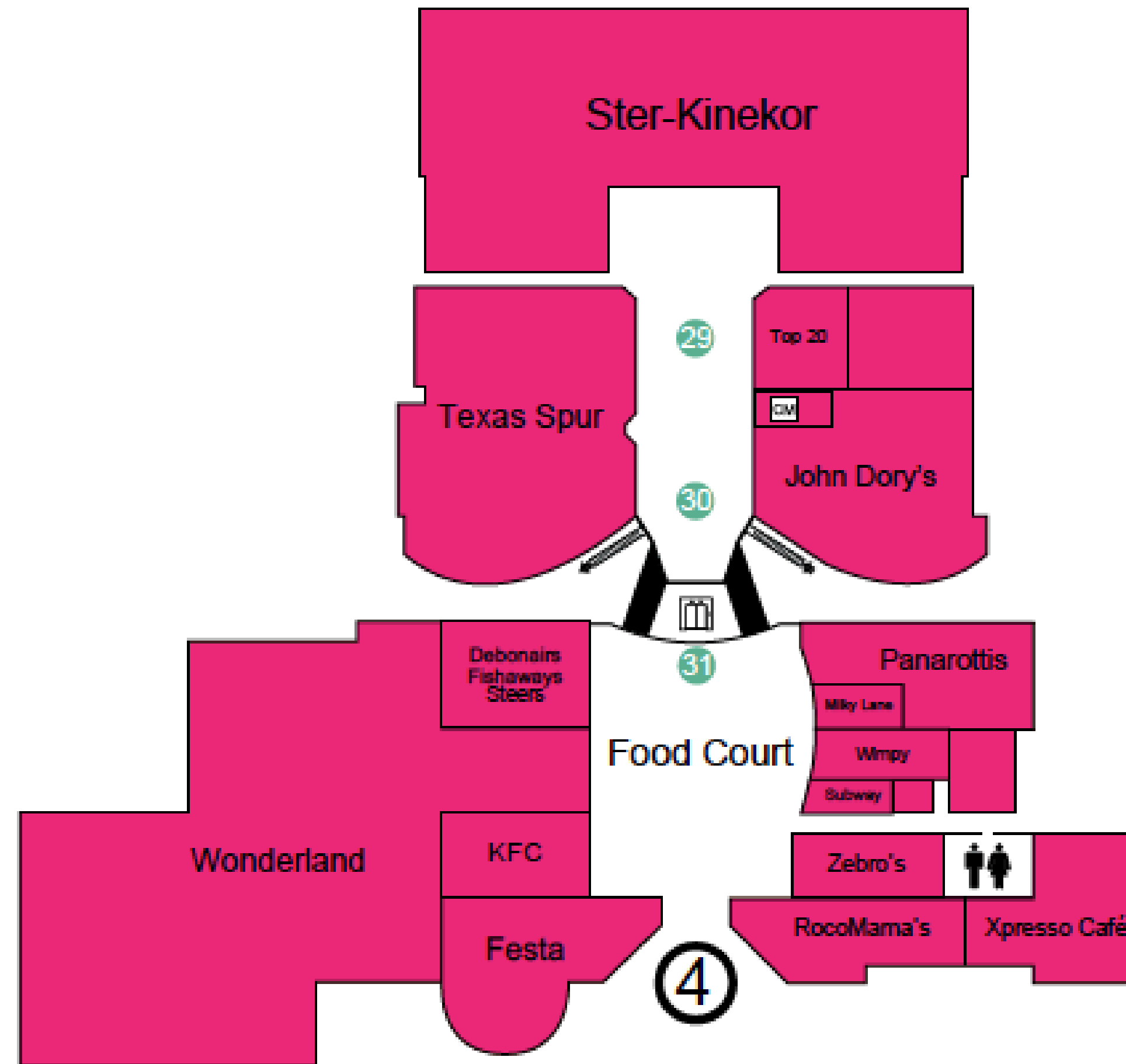
FLOOR PLAN
